Many charities know that gift annuity programs are regulated differently from state to state, but they might not know how substantially the degree of regulation varies. They might also not fully appreciate precisely what their responsibilities are, or even at what point they have responsibilities.

While certain states are well recognized for imposing strict requirements on gift annuity programs, almost every state has guidelines. In fact, of the 50 states, only four plus the District of Columbia are completely silent on the topic of gift annuity state regulation
