## Highlights of the 2025 Update

The 2025 edition of the *CGA Manual: The Complete Guide to Gift Annuities* includes updates to the Prototype Materials. A directory to the Prototype Materials can be found on pages xxii-xxiii of the manual. Although they are not listed in the directory, we have also updated for several states the annual filing documents that are included with the Prototype Materials.

The 2025 edition includes a re-written Best Practices chapter to improve its clarity and organization (Chapter 22), as well as numerous additions and clarifications.

Substantive changes or additions are noted below. Smaller edits that clarify an existing point or provide consistency in phrasing, punctuation, and format are not separately noted, nor are the many updates to state contacts and website links in the state regulatory chapters.

20.5	Clarified reporting of deduction for unrecovered investment in contract on a decedent's final income tax return.
21.10	Suspended until 1/1/2026: the rule in Canada that increases from 50% to 66.67% the taxable fraction of capital gain allocable to the present value of annuity payments that exceeds \$250,000
