



Actuarial Verification for Gift Annuity State Reserves

Report Format Requirements

These instructions are for clients using PG Calc's GiftWrap software to prepare CGA Reserve Reports for submission to PG Calc's Actuarial Verification Service.

Enter the appropriate criteria to produce the report for the state you wish to satisfy, then save report as described below.

Three files are required for each state report requiring actuarial verification.

1. Gift Annuity Reserves Report – Full Detail - pdf

Select: Show Full Report Detail

Select: Group by Mortality Table and Interest Rate

Select: Display Option - PDF

Name and save file using this format: name state reserves detail valuation date.pdf

Use 2-letter abbreviation for the state, with a space between each value.

Example: Memorial Hospital CA reserves detail 123123.pdf

Select: Show Full Report Detail

Select: Group by Mortality Table and Interest Rate

Select: Display Option – Raw Data

Name and save file using this format: name state reserves detail valuation date.csv

Use 2-letter abbreviation for the state, with a space between each value.

Example: Memorial Hospital CA reserves detail 12312.csv

Select: Show Only Mortality/Interest Subtotals and Grand Totals

Select: Group by Mortality Table and Interest Rate

Select: Display Option - PDF

Name and save file using this format: name state reserves No detail valuation date.pdf

Use 2-letter abbreviation for the state, with a space between each value.

Example: Memorial Hospital CA reserves No detail 123123.pdf
